**NEW GRANT APPLICATION GUIDELINES FOR
GRANT PERIOD JANUARY 1, 2024 – DECEMBER 31, 2024**

Thank you for your interest in the CIA's grant process. We are delighted that you are thinking of applying! Please read all the instructions carefully as they have been revised.

For your grant application to be considered, ten copies of all required materials must be received or postmarked by OCTOBER 16, 2023. No additional material will be accepted after the filing date. Incomplete applications will not be considered. Late applications will not be considered. It is your responsibility to confirm that your application has been received before the deadline, either by confirming email or tracking receipt.

Grant decisions will be announced to the applicants by letter in December 2024.

Grant checks will be awarded early in 2025.

In the past CIA awards have been awarded in amounts not exceeding \$10,000. This does not preclude larger grants exceeding this number in the future.

Guidelines:

- A. Only one application from an organization will be considered.
- B. Unallowable expenses: This is a project-based grant program. We do not fund general support for organizations. Grants will not be awarded for administrative salaries, general operating costs or expenses, endowments, fundraising drives or events, support of buildings, equipment, or other capital expenses unless demonstrated that such capital expenditures are essential to the success of the program. Grants will not be awarded to individuals or to conduit organizations that disburse funds to other individuals or other organizations.
- C. Funding priority will be given to programs with an outreach component. If your project offers such an outreach component, be sure to describe it fully.
- D. Funding priority will be given to programs from applicants who have previously supported CIA's mission statement.
- E. You must use the cover page provided with these guidelines. The cover page must be legible and filled out in its entirety.
- F. **The Application must include 10 copies of each of the following:**
 - a. A cover page.
 - b. A copy of your Mission Statement.
 - c. A list of the organization's Board members and officers. Be sure to include the names of the staff members responsible for your application project. Please indicate if you do not have any paid staff

members.

d. A copy of the IRS Determination Letter that states the organization's status as a 501 (c) (3) non-profit.

e. A current copy of the organization's operating budget, including the most recent audit or cover page of the tax return.

f. A detailed income and expense budget for the **project** for which you are applying for a grant. Include a detailed breakdown of what expenses the CIA grant for which you apply will be used to cover.

g. A description of the specific performance, project, or presentation for which the grant is requested, and any outreach program associated with this specific grant request. Include the amount requested, the date of the presentation, performance or project, your goals and objectives and expected outcomes. **YOUR PROGRAM MUST TAKE PLACE WITHIN THE 2024 GRANT YEAR PERIOD.**

h. A statement outlining the method you will use for evaluating your grant program. This evaluating method should be used in your final report, should you receive a grant.

If a grant is awarded to your organization, the CIA logo must be visible on all your printed programs and materials for the program funded. The logo can be downloaded from our website. Check the website for the current logo to be used.

CIA must receive a written evaluation of the grant program within sixty days of its presentation in order for the grantee to fulfill its obligations. The format and criteria will be provided with your award.

Grants must be used for the specific program as described in the application. If for any reason the program is cancelled or delayed, CIA must be notified at once. All monies must be returned to CIA within 30 days of cancellation or delay unless an extension is asked for and granted.
